



CHANGE-OF-NAME AGREEMENT

PCMG, Inc., formerly known as PC Mall Gov, Inc. (the "Contractor"), a corporation duly organized and existing under the laws of Delaware, and the United States of America (the "Government"), enter into this change-of-name agreement (the "Agreement") as of December 31, 2012.

(a) The parties agree to the following facts:

(1) The Government, represented by various Contracting Officers of NASA Goddard Space Flight Center, has entered into certain contracts and purchase orders with PC Mall Gov, Inc.:

- NNG07DA08B entered into by the NASA Goddard Space Flight Center, Mission Enabling Procurement Office, and PC Mall Gov, Inc. and effective as of May 1, 2007; and
- NNG07DA62B entered into by the NASA Goddard Space Flight Center, Mission Enabling Procurement Office, and PC Mall Gov, Inc. and effective as of June 8, 2007.


